Corey Burns, D.O. has joined Holy Cross Medical Group, a multi-specialty physician employed group of more than 130 physicians providing services throughout Broward County, as a primary care physician.

Dr. Burns recently completed his three-year family medicine residency at Halifax Health Medical Center of Daytona Beach, a 678-bed hospital that provides major medical and surgical services, including comprehensive stroke and cardiac care services, to Flagler and Volusia counties in Florida. He previously tutored and mentored first and second year medical students, as well as middle and high school students in math and science.

Dr. Burns graduated with a Bachelor of Science in Biology with minors in Business and Leadership from the Halmos College of Natural Sciences and Oceanography at Nova Southeastern University (NSU) and a Doctor of Osteopathic Medicine from the Dr. Kiran C. Patel College of Osteopathic Medicine at NSU. He was the recipient of the NSU President's Faculty Research and Development Award that enabled him to research the immune reactivity to gluten in patients with rheumatoid arthritis.

As a medical student, Dr. Burns was appointed as an Osteopathic Medical Student Representative to the American Osteopathic Association's (AOA) Bureau of Federal Health Programs (BFHP). During his oneyear term, he served as an advocate for physician and patient-centered policies at meetings with the offices of Senator Marco Rubio (R-FL), U.S. Congressman Neal Dunn, M.D. and other elected officials. In this role, he was able to be the voice of fellow medical students during policy workshops, especially in conversations regarding the funding of Graduate Medical Education (GME).

An active volunteer, Dr. Burns participated in Volusia Volunteers in Medicine, providing care at a free medical clinic offering primary and preventative medical services to the low-income residents of Volusia County who have no health insurance; was a pantry volunteer for the St. Petersburg Free Clinic; built homes for Habitat for Humanity; and prepared and served meals at Jubilee Center of South Broward. As a medical student, he assisted internal medicine physicians on an outreach trip to Guatemala, where he learned to adapt to diverse work environments and refined his medical Spanish skills.

She received a \$20,000 grant from AOFAS to investigate the optimization of leg elevation after ankle fracture fixation using Near Infra-Red Spectroscopy and physiological parameters. She also serves on the AOFAS Young Physician's Committee and has hosted podeasts and helps prepare the next generation of foot and ankle surgeons.

Outside of her practice and academia, Dr. Moncman is an impressive distance runner. In 2012, she became the youngest female and one of only 78 people to complete the 4 Deserts Grand Slam, where athletes run 250km six-stage ultramarathons in Antarctica; Gobi Desert in China; Sahara Desert in Egypt; and Atacama Desert in Chile, all in the same calendar year. A native of Newtown, Connecticut, she founded Newtown Proud Newtown Strong, which raised \$250,000 for the families of the Sandy Hook Elementary School shooting victims and for a scholarship fund.

She said they were looking for a sales and marketing leader with a passion for improving the health and well-being of the community, and told Denoux she thought she'd be a great fit for the role. "Sure enough I applied and that's how I started in healthcare." Denoux spent almost four years there as director of development, then more than 10 years at Baptist Health South Florida as director of development and corporate partnerships, and now nearly two years at Holy Cross Health.

Denoux said her responsibilities at Holy Cross Health include "the operational and strategic leadership of the health system's fundraising efforts; campaigns; donor engagement; principal, major, annual, and planned giving; corporate partnerships; events; board engagement; concierge services; grateful patient and clinician fundraising programs; fund management; staff recruitment and development; and community relations." In addition, she serves as a philanthropy leadership council member, working with peers at other hospitals to roll out new programs, procedures, and best practices so that all of Trinity Health is working cohesively on fundraising efforts.

Denoux is grateful for her transition to healthcare, stating, "I have the privilege of contributing to people's well-being and supporting the community in improving their health. Every day brings new challenges, and no two days are ever the same."

In addition to helping the community, Denoux is interested in encouraging other philanthropy leaders to become involved with ACHE – American College of Healthcare Executives – as she herself did several months ago. Her reason for joining was that as part of an executive leadership team and being surrounded by healthcare administrators, "I felt if I'm really going to help set the strategic priorities and be part of the decision-making of the hospital – I needed to have a deeper understanding of the healthcare industry overall."

Her intent was to "learn more so that I could bring that experience to my day-today work in philanthropy, and also be able to further the mission and help support my colleagues at the executive level." Now, after attending various ACHE events and meeting other members, she said she is getting more exposure to healthcare leaders and learning ways to overcome challenges in healthcare. "It definitely has been an exciting opportunity for me."

Since joining ACHE, however, Denoux has discovered that few development and philanthropy leaders are involved with the organization, and she would like to urge others to join. In emphasizing the importance, she explained that Holy Cross is currently engaged in several large capital projects. "We're going to be building a new CT for our emergency department and a new family health center, in addition to renovating the whole outpatient rehabilitation center at the hospital. All of these capital projects will be funded 100 percent by philanthropy."

She continued, "Many assume that joining ACHE is only for healthcare executives or administrators, but I see it as a valuable opportunity for anyone in the industry, regardless of their position," Denoux said. "I encourage those who are passionate about healthcare, even at a junior level, to get involved with ACHE. It's an excellent platform for networking and learning, especially for young professionals."
