

2021 QUALITY PLAN AT A GLANCE

PREVENTATIVE SCREENINGS

- Annual Blood Pressure; document follow-up plan if elevated
- Annual LDL with statin if ≥190
- Annual BMI; document follow-up plan if abnormal
- Breast cancer screening women age 40-74 (every 2 years)
- Colorectal Cancer Screening all patients age 50-75 (every 1-10 years, varies by screening type)
- Tobacco Use Screening; council and document cessation intervention for every office visit if current user
- Annual PHQ-9 screening; if PHQ-9 (+), create and document a care plan; if PHQ-9 score >9, antidepressant for ≥6 months and rescreen in 12 months

EFFICACY/ACCESS

- Lower All-Cause Readmissions
- Lower Ambulatory Case Sensitive Condition Admissions: COPD or Asthma (ages ≥ 40 years), CHF, PNA, HTN, UTI
- Post-Discharge Patients:
 - Seen by PCP within 7 days
 - Review of medication reconciliation and document "same" or "change in meds"
- Lower ED: Visits per 1,000 patients/year and patients with ≥ 3 visits per year
- ACCESS: Expand office hours; offer next, 2nd or 3rd available appointments; use Ambulatory Care Centers

HCPP CITIZEN

- Code and document accurately
- Use generic rather than brand when appropriate
- Lower number of prescriptions per patient
- Lower overall cost of care
- Improve patient satisfaction and experience
- Attend HCPP meetings & meet with HCPP PTS

ACUTE/CHRONIC CONDITIONS

- Acute uncomplicated low back pain: no imaging for 28 days
- Acute bronchitis: no antibiotics prescribed or dispensed on or within 3 days of visit
- ASCVD: All patients need statins
- BP <140/90 for all patients with HTN
- COPD: Spirometry testing age ≥40 years
- Asthma: Medication Management ages 5-64 years

DIABETES

- Annual HbAic and <8.0
- Nephropathy assessments (urine microalbumin)
- Annual screening tests for DM Retinopathy
- Statin therapy for LDL >70 (ages 40-75)
- Routine Screening: Short-term/long-term control, amputation risk

ALL PATIENTS OVER 65

- Annual Office visit / AWV
- Annual Fall Risk Screening
- Annual Influenza immunization (Oct.—Mar.)
- Pneumonia vaccine age 65, every 5 years

IMMUNIZATIONS

- Annual Influenza immunization (Oct.—Mar.)
- Shingles vaccine age 50 with prior Chicken Pox exposure
- Tetanus Vaccine every 10 years

PEDIATRICS

- Well-Child Visits: ≥6 visits total from ages o-15 months
- Annual Well-Child Visits. Ages 12-21
- Child immunizations
- Pharyngitis: Antibiotic care ages 2-18 years with positive strep test
- URI: Antibiotic care ages 3 months-18 years

WOMENS HEALTH

- Pregnancy; prenatal and postpartum care
- Osteoperosis Management in women who've had a fracture, bone density screening 180 days post fracture
- Cervical Cancer Screening women age 21-64 (every 3 years)
